In the absence of the Chair of the Parish Council Cllr Jones took the chair for the meeting.

Sue Peters, on behalf of St Denys Church, explained issues facing the Church and principally the need for repairs to the church clock.

The Clerk confirmed that the Parish Council could provide help by virtue of Parish Council Act (1957) pt1 s2: *Power to provide public clocks.*

A parish council may provide, maintain and light such public clocks within the parish as they consider necessary cause them to be installed on or against any premises or in any other place the situation of which may be convenient.

Some surprise was expressed at this and ensuing discussions considered the definition of a clock as "public."

The Clerk was asked to clarify the situation at the next meeting.

/1 To review progress on speeding concerns

The Clerk reported that results of the recent speed survey conducted by Leics Highways.

Extensive discussion followed. Cllr Nelson asserted that the results demonstrated the need for immediate action. Cllr Greasley indicated a similar cause for concern in Goadby Marwood.

County Councillor Bryan Lovegrove outlined the funds available to him to support traffic problems in parishes within his District but cautioned that the funds available were limited in comparison to the many pressing needs.

Further he outlined how the problem(s) could be progressed through his liaison with County Council Highways officials, a site meeting and attendance at a future Parish Council meeting by said officials.

The Parish Council agreed to ask for the help from Councillor Lovegrove's fund with the purchase of three VAS devices (probably mobile) and that he take up the issues with Leics Highways officials with the possibility of their attendance at a future Parish Council meeting.
