Public Participation:

There was discussion raised by a resident over whether it was necessary to install a fence or hedge to prevent dogs running amok on the allotments, it was eventually decided to wait until next year before going ahead with any of the suggestions. It was however thought that a hedge certainly across the bottom of the allotments was the best option as free whips could be obtained from the Woodland Trust and it was cheaper than a fence. It was felt that the new signage had minimal impact on stopping the problem and that possibly educating dog owners would help. It was therefore agreed to hold an open day in the spring to explain how allotments worked and why dogs on allotments was not a good idea. Cllrs Craft & Bettley plus Derek Janes offered to organize this and make their allotments open to the public.

Cllr Rhodes advised that the recycling depot at Bottesford would be shut for several months from January 2021 for essential drainage work to be carried out on the site. He also had advised that the County Council had decided prior to the Government actually agreeing to the proposal to supply free school meals to children over the Christmas holiday period, at a cost of £180,000.00 per week. The fact the government would now foot the bill was good news as it would have amounted to around half a million pounds up to the end of the year.

Eaton:

Cherry trees in Churchyard

The two Cherry trees at the entrance to the Churchyard on inspection had found to be in a poor state one was dead and was to be removed the other was dying and would be removed in due course. The stumps of both trees would be stump ground to enable replacements to be planted in the future if required, the total cost would be £500.00.

Fencing in the Allotments:

This matter was discussed during public participation, however further discussion took place concerning the responsibilities of the Parish Council regarding dog owners and where the Community Park Association fitted in regarding this matter. The main reason for dog walkers using the allotments was to access the recreational park because the other entrance was on Main Street at the entrance to the village, which was not ideal for a variety of reasons. It was felt that the committee of the community park association should be involved in resolving this problem. It was suggested that maybe a Parish Councillor should at attend the Associations meetings and Derek Janes offered to raise the matter at the next meeting of the Association. It was further agreed Highways should be contacted regarding speeding traffic on Main Street past entrance to recreational field, Clerk to contact Highways.

Street Lighting:

The Clerk provided information regarding the cost of running the street lights and whether it was worth replacing the older lanterns with the new LED type which were much more energy efficient and needed little maintenance. Whilst there would be savings it would take the best part of 10 years to recover the cost of the new lanterns. After discussion it was agreed to adopt a policy of replacing the older lights as and when they ceased to work, and going forward look at a planned program of replacement as when finances permitted.

The Clerk said the Scalford facebook page was mainly used for getting information out to residents quickly for instance the problem regarding dogs on the allotment, the bonfire which had been abused by residents putting none allotment material on it for burning, the Amazon Smile which might help funds for the Herbage Charity. Cllr Crafts offered to photograph the bonfire and put it on facebook along with some text, also text re Amazon Smile and also information regarding the allotment open day.
