a) Herbage Charity

b) Church Walk:

It was agreed to arrange for Church Walk and Main St to Chapel St to be cleared as soon as possible Cllr Hardy had found a non-toxic product that would kill the moss and it was agreed this would be applied to Church walk in the spring.

c) Allotment Boundaries:

It was agreed to write to residents whose properties adjoined the allotments and ask them to contact either Cllr Bettley or Hardy to discuss the matter of the boundaries. Cllr Bettley advised that hedges and trees in the allotments were in urgent need of attention.

d) Additional taps in allotments:

Cllr Bettley to discus with Tony Allen the feasibility of adding further taps.

e) Yew Trees in Churchyard:

Budget prices had been obtained for both felling 3 trees or reducing to approx. 2 metres, the cheaper option being to fell the trees. It was unclear what the Parochial Council wanted so it was agreed to notify them of the Of the Parish Councils preference to fell. The number of trees needing attention had also apparently risen to 5.
